### **Executive Summary**

#### 1. Introduction

The City of Erie, Pennsylvania is an entitlement community under the U.S. Department of Housing and Urban Development's (HUD) Community Development Block Grant Program (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grant Program (ESG). The City of Erie prepared its Five Year Consolidated Plan (CP) in FY 2020. This document is for the period July 1, 2024 through June 30, 2025. The Consolidated Plan is a strategic plan to implement federal programs for housing and community development activities within the City of Erie and outlines how the proposed activities will principally benefit low-and moderate-income individuals. The Consolidated Plan is a requirement of the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG) Program that must be completed by the entitlement community every five (5) years in conjunction with an update to the City's Analysis of Impediments to Fair Housing Choice (AI). The City of Erie has participated in the Regional Analysis of Impediments to Fair Housing Choice prepared by Destination Erie: A Regional Vision (HUD Sustainable Communities), a consortium of regional stakeholders envisioning the County's future and creating a strategy to meet the region's economic, social, and environmental challenges of the 21st century. The City of Erie will take appropriate actions to overcome the effects of any impediments identified through the Analysis. The City of Erie approved and adopted the Regional Analysis of Impediments to Fair Housing Choice for the City of Erie, Pennsylvania on December 16, 2015. The City intends to complete a new Affirmatively Furthering Fair Housing citizen participation process once it receives HUD guidance.

The Five Year Consolidated Plan establishes goals the City of Erie proposes for the next five (5) year period and outlines specific initiatives the City will undertake to address these goals by encouraging the development of decent housing, promoting a suitable living environment and expanding economic opportunities. The Five Year Consolidated Plan is a collaborative planning process between the City, the community at large, social service agencies, housing providers, community development groups, and economic development agencies. The process was implemented through a series of public meetings, stakeholder surveys, statistical data, and reviews of previous community development plans.

As of the date of the Draft FY 2024 Annual Plan being put on public display, the City of Erie had not yet received notification from HUD of its annual allocation amounts for the CDBG, HOME and ESG programs. Therefore, the City of Erie prepared the Draft FY 2024 Annual Plan using estimates based on the FY 2023 HUD allocations. The Total amount of CDBG, HOME and ESG funding estimated to be available to the City for the Fifth Annual Plan for FY 2024 is \$4,252,162, including entitlement and program income dollars. HOME funds will be distributed to eligible HOME activities that address affordable housing and improve the quality of life for residents. Programs include housing rehabilitation, homebuyer programs, and rental housing for qualified residents. ESG funds will be distributed to eligible activities that address the needs of Erie's homeless population. Projects include both emergency and transitional shelters, along with essential services. The purpose of the Homeless Assistance Program is to reduce the incidence of homelessness in Continuum of Care (CoC) communities by assisting homeless individuals and families in quickly transitioning to self-sufficiency and permanent

housing as authorized under Title IV of the McKinney-Vento Homeless Assistance Act. CDBG funding will address a variety of needs, including affordable housing and non-housing needs. CDBG funding will be distributed to public infrastructure improvements, clearance, public services, economic development, technical assistance and rehabilitation.

### 2. Summarize the objectives and outcomes identified in the Plan

The following six (6) priorities and subsequent goals/strategies have been identified for the City of Erie for the period of FY 2020 through FY 2024 for the Community Development Block Grant (CDBG) Program, HOME Investment Partnerships (HOME) Program, and Emergency Solutions Grant Program (ESG). Full descriptions of the goals and strategies associated with this Annual Action Plan are included in the AP20 Annual Goals section.

**Housing Priority** – (High Priority) There is a need to improve the quality of the housing stock in the community by increasing the amount of decent, safe, sound, and accessible housing for homeowners, renters, and homebuyers that is affordable to low and moderate income persons and families. Goals/Strategies: HS1 Housing Rehabilitation; HS2 Rental Rehabilitation; HS3 Housing Construction; HS4 Fair Housing; HS5 Home Ownership; HS6 Public Housing.

Homeless Priority – (Low Priority) There is a need for housing and support services for homeless persons, and persons who are at risk of becoming homeless. Goals/Strategies: HO1 Continuum of Care; HO2 Operation/Support; HO3 Prevention and Housing; HO4 Housing; HO5 Permanent Housing.

Other Special Needs Priority – (Low Priority) There is a continuing need for affordable housing, services, and facilities for persons with special needs and the disabled. Goals/Strategies: SN1 Housing; SN2 Social Services; SN3 Accessibility.

**Community Development Priority** – (High Priority) There is a need to improve the public and community facilities, infrastructure, public services, and the quality of life for all residents in the community. Goals/Strategies: CD1 Community Facilities; CD2 Infrastructure; CD3 Public Services; CD4 Accessibility; CD5 Public Safety; CD6 Code Enforcement; CD7 Clearance; CD8 Revitalization; CD9 Historic Preservation.

**Economic Development Priority**– (Low Priority) There is a need to increase employment, self-sufficiency, education, job training, technical assistance, and economic empowerment of low and moderate income residents in the community. Goals/Strategies: ED1 Employment; ED2 Financial Assistance; ED3 Redevelopment Program; ED4 Financial Incentives.

**Administration, Planning, and Management Priority** – (High Priority) There is a need for planning, administration, management and oversight of Federal, state, and local funded programs. Goal/Strategy: AM1 Overall Coordination.

### 3. Evaluation of past performance

The City of Erie strives to equitably allocate Community Development Block Grant (CDBG) funds to income eligible areas and persons throughout the City and has funded activities during the past year to meet the City's FY 2020 to FY 2024 Five Year Consolidated Plan and Fourth Annual Action Plan goals and objectives. Erie's CDBG Program regularly meets the performance standards established by HUD. Each year the City prepares its Consolidated Annual Performance Report (CAPER) which summarizes the objectives it has addressed in achieving the Con Plan goals and objectives. The City submits its CAPER

within ninety (90) days of the completion of each new program year. Copies of the CAPER are available for review at the City of Erie's Department of Economic and Community Development and online at http://www.erie.pa.us/Departments/EconomicandCommunityDevelopment.

In the FY 2022 CAPER, the City of Erie expended 100.00% of its CDBG funds to benefit low and moderate income persons. The City expended 16.99% of its funds during the FY 2022 CAPER period on public service, which is above the statutory maximum of 15%, but within the City's allowable cap of 20.96% granted the City of Erie per an August 3, 2018 memorandum issued by HUD Headquarters, allowing the City to obligate funds for public service activities not to exceed the higher of \$778,960 or 20.96% the annual CDBG grant amount, plus 15 percent of the amount of program income it received during the previous program year. The City expended 17.01% of its funds during the 2022 CAPER period on Planning and Administration, which is below the statutory maximum of 20%. The City did not meet the required 1.5 maximum drawdown ratio. The City's ratio was 1.64 as of April 28, 2023.

### 4. Summary of Citizen Participation Process and consultation process

The City of Erie, in compliance with the City's Citizen Participation Plan, advertised and held two (2) public hearings on March 4, 2024 at 10am and 6pm and will hold two (2) public hearings on April 15, 2024 at 10am and 6pm on the needs of the City of Erie and collect input on the proposed activities to be funded. Residents were given the opportunity to discuss the City's CDBG Program and to offer their suggestions on future CDBG program priorities on March 4, 2024. The public hearings were advertised in the *Erie Times News* on February 16, 2024, and the second public hearings were advertised on March 27, 2024. The City maintains a stakeholder contact list for the Economic and Community Development program. All stakeholders received applications and emails notifying the listees of all public hearings and meetings. A copy of the list can be found in the attached Citizen Participation materials.

The City of Erie advertised on March 27, 2024 that a "Draft Plan" was placed on display on the City's website at www.cityof.erie.pa.us and hard copies of the plan were available for review at the following locations: Erie City Hall, Economic and Community Development, Room 404, 626 State Street, Erie, PA 16501; Blasco Memorial Library; Booker T. Washington Center; JFK Center; and MLK Center. The "Draft Plan" will be available from March 27, 2024 until April 26, 2024 for review and comment. The draft plan review period was advertised in the *Erie Times News* on March 27, 2024. The City developed the Fifth Year Annual Plan based on the input received from residents and stakeholders through applications, public hearings, and draft plan review comments.

### 5. Summary of public comments

The City of Erie held its First Public Hearings on March 4, 2024 at 10:00 AM and 6:00 PM at City Hall as well as livestreamed on the City's Facebook page, at the "live" tab on the City's YouTube channel and online through the City's government channel at <a href="https://www.camerie.org/vod">www.camerie.org/vod</a>.

The City of Erie will hold its Second Public Hearings on April 15 2024 at 10:00 AM and 6:00 PM at City Hall as well as livestreamed on the City's Facebook page, at the "live" tab on the City's YouTube channel and online through the City's government channel at www.camerie.org/vod

#### 7. Summary

The overall goal of the Five Year Consolidated Plan and Annual Action Plan is to improve the living conditions for all residents in the City of Erie, to create a suitable and sustainable living environment, and to address the housing and community development needs of the City. The Five Year Consolidated Planning process requires the City to state in a single document its strategy to pursue goals for all housing, community development, and planning programs. The City uses the Consolidated Plan's goals and objectives to allocate CDBG funds, including this Fourth Year Annual Action Plan, and to provide direction to other partners addressing the housing and community development needs of the low and moderate income population of the City of Erie. HUD will evaluate the City's performance under the Five Year Consolidated Plan against these goals.

### AP-10 Consultation – 91.100, 91.200(b), 91.215(l)

### 1. Introduction

The City of Erie conducted a series of public meetings to solicit input into the preparation of the Fifth Annual Plan. The meetings were advertised in the *Erie Times News* and the City of Erie website <a href="https://cityof.erie.pa.us">https://cityof.erie.pa.us</a>. Input from the meetings was used in the development of specific strategies, goals, and priorities for the Fourth Year Annual Action Plan. Each year, as a part of the CDBG, HOME, and ESG application process, local agencies/organizations are invited to submit proposals for grant eligible activities and to participate in the consultation process through attending public hearings and/or responding directly to the correspondence. A complete list of agencies contacted and representatives that participated in meetings can be found in the Citizen Participation attachment.

All CDBG and HOME applicants (except projects operated by City of Erie departments) were invited to provide presentations and additional information on their proposed programs with DECD staff, the Mayor and Mayor's Office Staff and some members of City Council on February 5 and 9, 2024. Evening public hearings were held again this year. A study session with City Council was held on March 19, 2024 to present proposed activities and funding levels.

The City consults with the Erie Redevelopment Authority (ERA) regarding lead-based paint hazards, including addressing housing units with children. The City regularly conducts outreach for persons living in slum/blight areas, including through the Citizen Participation process and coordination with the Blighted Property Review Task Force (see also AP-75).

A Federal Byrne Criminal Justice grant has been operating in Erie's East Side in conjunction with Code Enforcement, ERA, and neighborhood groups. The \$955,000 grant will be used to assist with reducing crime in a specific target area with a population of roughly 9,000 individuals. A BCJI coordinator has been hired to coordinate efforts with a cross sector team to develop strategies. The Action Plan was approved in August, 2022. Project is currently in the implementation phase. Strategies listed in the Action Plan began in January 2023.

Provide a concise summary of the jurisdiction's activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health and service agencies (91.215(I))

The City of Erie acts as the single point of contact to coordinate efforts between public and assisted housing providers, as well as private and governmental health, mental health, and social service agencies. The City works with the following agencies to enhance funding and service allocations to address the housing and community development needs of the City:

- City of Erie Housing Authority: coordinating on affordable housing (Section 8 Housing Choice Vouchers and Public Housing improvements) especially for the very low and extremely low income residents of the City.
- *Social Services Agencies:* coordinating on funding allocations to improve the availability and efficacy of social service programs for low and moderate income persons.

Housing Providers: coordinating on rehabilitation, development and affordable housing needs
for low and moderate income households. All members of the housing and social service
community are encouraged to actively participate on the CoC's activities.

Each year, as part of the CDBG, HOME, and ESG application planning process, local agencies and organizations are invited to submit proposals for project funding for eligible project activities. These groups participate in the planning process by attending the public hearings and informational meetings, as well as commenting on draft plans.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

The City of Erie is a member of the Home Team Homeless and Housing Coalition / Erie County and City Continuum of Care (CoC). The CoC has branded itself as the Home Team. The Home Team, formed in 1997, was created to promote a comprehensive, collaborative and sustained community approach to homelessness. The Home Team consists of local government representatives, service providers, business owners, consumers, and concerned citizens. The following agencies comprise the Home Team: City of Erie School District; Community of Caring; Community Health Net – Health Care for Homeless; Community Shelter Services; Department of Human Services; Department of Veterans Affairs; Erie City Mission; Erie Department of Economic and Community Development; Erie County Assistance Office; Erie County Care Management; Erie County Community Support Program; Erie County Health Department; Erie DAWN; Erie United Methodist Alliance/Project Hope; Family Services of NW PA; Gaudenzia Erie; GECAC; Housing And Neighborhood Development Services; Mental Health Association of Northwestern PA; Mercy Center for Women; Mercyhurst Civic Institute; Northwest Tri County IU # 5; Partnership of Women Religious (POWR); Penn State Erie, CORE; Safe Horizons; SafeNet; St. Martin Center, Inc.; Stairways, Inc.; Tirak & Huber; United Way of Erie County; and Voices for Independence. The Home Team meets bimonthly to work toward eradicating homelessness.

The CoC implemented a coordinated entry system in January 2018, which will benefit homeless outreach and assessment processes, and coordinated entry was awarded extra money in the 2019 CoC grant to expand that system. The agencies regularly communicate on barriers and strategies to prevent homelessness, particularly through the Erie County Home Team Homeless and Housing Coalition, the Executive Committee and its subcommittees. The Erie County Home Team Homeless and Housing Coalition restructured the committees in 2019, with the main committee being the Executive Committee. This committee is the governance board for the Home Team, and they vote on all housing issues for the Erie County Home Team. The committee consists of human service providers, MH providers, formerly homeless, County DHS representative, City housing representative, a health department representative, and a landlord. Sub-committees are Client Services Committee, Data Committee, Coordinated Entry Committee, Homelessness and Healthcare Committee, Marketing Committee, Project Ranking Committee, and the Single Point in Time Committee. The Sub-Committees work on providing improved access and enhancement of services for homeless individuals as well as data collection to better review outcomes and quality of housing services. HMIS reports are provided to Erie County Home Team Homeless and Housing Coalition to review aggregate information on the area's homeless population, which can help identify trends, characteristics, and needs of this population. Erie County Home Team Homeless and Housing Coalition meetings are open to the public. Local nonprofits,

education providers, Veteran representatives, social service agencies, and community members regularly contribute to the Home Team's efforts.

In Erie County, the six emergency shelters have succeeded in providing shelter for those in need. Individuals who are homeless are provided with a safe environment but it has become increasingly difficult for people to easily leave shelter. The Housing First approach is a concept where housing individuals first, regardless of secondary issues, is the goal. Further, the Home Team collects data related to the homeless services system in Erie County. The purpose of data collection is to ensure non-duplication of resources and to identify and address major gaps in the system.

Describe consultation with the Continuum(s) of Care that serves the jurisdiction's area in determining how to allocate ESG funds, develop performance standards for and evaluate outcomes of projects and activities assisted by ESG funds, and develop funding, policies and procedures for the operation and administration of HMIS

The City of Erie actively participates in the CoC and consults with the CoC on the allocation of the ESG funds, which are used for rapid rehousing and operating costs for emergency shelters and transitional housing facilities. It was determined that the rapid rehousing be administered by one agency and that each shelter would be allocated a set amount of funds for their use but not to be so restrictive that the funds would be unexpended. Based on CoC consultation, the City implemented a policies to reduce barriers to individuals and families accessing the Rapid Re-Housing program (see AP-65 for discussion). The CoC is surveyed for the use of ESG funds and are invited to the public hearings for the allocations. The City of Erie also utilizes the CoC for their reports and to ascertain the need in the City. The CoC participates in the statewide discussion on ESG through direct participation at state meetings.

The City regularly collaborates with the HMIS Coordinator for the CAPER and coordinated efforts on data collection/quality. During FY2017, the CoC began strategic planning efforts that include the coordinated assessment/entry system and performance measures. The City will continue to work with the CoC on these initiatives to align ESG activities and programs.

### Narrative (optional)

The City of Erie Department of Economic and Community Development is the lead planning and administrating agency for the City's CDBG, HOME, and ESG programs. Close coordination is maintained between the Department and other City departments to ensure the needs for affordable housing and community development are being met. Cooperation extends beyond the City limits to the county and state level. Communication between the City's program and the County's program exist to ensure activities are coordinated and efficiently utilize CDBG, HOME, and ESG funds. The Vision of the City of Erie's Five Year Consolidated Plan and Fourth Annual Action Plan seeks to develop a viable community by promoting integrated approaches that provide decent housing, a suitable living environment, and expand economic opportunities for low and moderate income persons. The primary means towards this end is the development of partnerships among all levels of government and the private sector, including for-profit and nonprofit organizations. The Fourth Annual Action Plan is an application for FY 2023 CDBG, HOME, and ESG funds under HUD's formula grant program. The combined Plans act as a strategic plan to be followed by the City in carrying out federal programs.

# 1. Summary of citizen participation process/Efforts made to broaden citizen participation Summarize citizen participation process and how it impacted goal-setting

The preparation process for the Fifth Annual Action Plan incorporated a number of actions that encouraged citizen participation. The City contacted local agencies and organizations to respond to the City's request for proposals (RFPs) for CDBG, HOME, and ESG funding. Notification of the public hearing was also published in the Erie Times News and application materials were available to the public by mail and online at the City's website. The City provided technical assistance to applicants upon request and met with all CDBG Public Service, Public Facilities and HOME applicants to learn more about agency programs benefiting low-to-moderate income people. At the public hearings many agencies gave positive feedback on the increased opportunities for engagement this year. In alignment with the City's Citizen Participation Plan, the City held public needs hearings on March 4, 2024 during the development phase of the Annual Plan, and will hold a second series of public hearings on April 15, 2024 to discuss proposed FY 2024 projects during the thirty (30) day draft review and comment period. The City will accept comments on needs that citizens may feel were not addressed from the list of proposed projects.

The City developed the Fifth Annual Action Plan based on the input received from residents and stakeholders through application proposals, public hearings, meetings, and draft plan review comments. All stakeholders on the City's CDBG contact list received application proposals, hand-outs, and emails notifying them of the public hearing. A copy of the list can be found in the Citizen Participation attachment.

Residents were encouraged to provide comments on the Fifth Annual Action Plan at the Public Hearings held on March 4, 2024. This is the eighth year the City expanded Public Hearing times to include evening sessions to provide additional options to citizens who may be unable to attend morning hearings. Public comments and input were invited to be submitted to the City of Erie's Department of Economic and Community Development. See Citizen Participation appendix for a details.

#### 2024 Narrative

#### Actions planned during the next year to address the needs of public housing

The Housing Authority of the City of Erie (HACE) contracted with the Nelrod group to undertake an Energy Audit. The field work for this project is complete and HACE expects to see the completed Energy Audit by the end of April, 2024. 2024 capital fund construction projects include: replacing the roof at Friendship Apartments, Replacing the roofs and siding at five building in the Lake City Development, replace 36 scattered site roofs, replace stoops and handrails at Lake City Development, renovate the management office at the John Horan Garden Apartments, renovate 100 bathrooms at Harbor Homes and undertake façade improvements at Better Housing to include replacing the siding and stucco with cement board siding and replacing the entry steps.

## Actions to encourage public housing residents to become more involved in management and participate in homeownership

The Housing Authority of the City of Erie (HACE) encourages resident participation in its Tenant Councils and Resident Advisory Boards. Educating residents on the purpose of the tenant councils and resident advisory boards, and how their feedback will be used to inform planning efforts, can help encourage increased participation. HACE also conducts a bi-annual resident satisfaction survey to gauge the perceptions of safety and problems in the neighborhoods and determine actions for improving living conditions. A survey was conducted in 2022 and the results show that HACE residents have a high level of satisfaction with their housing and services as was the case in previous surveys. The next Resident Satisfaction Survey will be scheduled for 2024.

HACE will also continue to encourage participation in its Section 8 and public housing homeownership programs. The Family Self Sufficiency program helps renters escrow dollars to put toward purchase of a home or vehicle to aid in employment. The Housing Authority indicated that over 50% of the participants are New American households. Between Public Housing and the Housing Choice Voucher program 102 households participate in the program.

The Housing Authority continued to see an increase in households with earned income. In 2023, 1,298 households had employment as a source of income. There were 971 (+228) public housing households and 327 (-22) Section 8 households employed as of December 31, 2023. This is a total net increase of 206 from 2023. Of the families newly housed in public housing in 2023, 109 (46%) of 253 families had employment as a source of income. In 2023, 169 working families enjoyed the benefits of the Authority's flat rent or ceiling rent, which caps the household rent, regardless of income.

Twelve (12) families graduated from the Section 8/Public Housing Family Self Sufficiency Program in 2023. There were two (2) graduates that purchased homes in 2023.

# AP-65 Homeless and Other Special Needs Activities – 91.220(i) Introduction

The Home Team was created to promote a comprehensive, collaborative and sustained community approach to homelessness in Erie County. The Home Team meets bimonthly to work toward eradicating homelessness. In addition, the Home Team collects data related to the homeless services system in Erie County. The purpose of data collection is to ensure non-duplication of resources and to identify and address major gaps in the system. Ultimately, the Home Team's goal is to enable the person or family experiencing homelessness to become self-sufficient and to move into permanent housing.

# Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

## Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The Erie City-County Continuum of Care adopted Coordinated Entry System (CES) in January 2018. The CES provides a strategy to quickly move people from homelessness to permanent housing by establishing a streamlined and uniform method of serving clients in need of housing crisis services, using a single point of entry model; reducing burden on both client and provider by having a unified systemic approach to quickly identify, assess, and refer clients to the best intervention to meet clients' specific needs at first contact; increasing collaboration between agencies in serving client needs more effectively and efficiently; and collecting data on community trends of housing needs to better target limited resources. When households or individuals present to the Continuum, the household is assessed using a vulnerability index to determine the type of housing intervention that will most adequately address their need.

#### Addressing the emergency and transitional housing needs of homeless persons

As discussed above, all persons presenting to the continuum are assessed using a vulnerability index (to determine the type of housing intervention that will most adequately address their need. In addition, a Master List meeting with Coordinated Entry, Housing providers and Erie County DHS is used to further prioritize individuals/households for openings. Potential interventions include transitional housing, rapid rehousing or permanent supportive housing. There are currently emergency shelters available for homeless individuals and families, including victims of domestic violence. The CoC has adopted housing first, which seeks to place persons in permanent housing as quickly as possible, then provide supportive services to promote stability in housing.

The City of Erie will support six emergency shelters and three transitional housing facilities using CDBG and ESG dollars in FY2024.

Helping homeless persons (especially chronically homeless individuals and families, families

with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Ending chronic homelessness is a priority for the CoC, and as such, has prioritized serving persons experiencing chronic homelessness in all of its permanent supportive housing beds. As discussed above, all persons presenting to the continuum of are assessed using a vulnerability index to determine the type of housing intervention that will most adequately address their need. The CoC has adopted housing first, which seeks to place persons in permanent housing as quickly as possible, then provide supportive services to promote stability in housing.

The City of Erie will utilize ESG dollars to support rapid rehousing assistance efforts for literally homeless individuals and households (administered by GECAC).

Help low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families who are likely to become homeless after being discharged from a publicly funded institution or system of care, or who are receiving assistance from public and private agencies that address housing, health, social services, employment, education or youth needs

While the City of Erie and County follow Pennsylvania state mandated procedures for discharge from mental health institutions, stakeholders reported a widespread need for medical respite care to ensure folks discharging from substance treatment centers, hospitals and mental health institutions receive interim care prior to placement in supportive housing. The stakeholder outreach process consistently identified a need for increased supportive services for folks exiting institutions that extend into housing placement, and don't end upon placement in permanent housing. GECAC and St. Martin Center receive County Homeless Assistance Program dollars for homeless prevention activities; assistance includes rental and utility assistance. In addition, GECAC also administers weatherization and energy education programs to help households reduce utility bills and avoid evictions and shutoffs. CDBG and ESG dollars will not be used for prevention activities in 2024.

### AP-75 Barriers to affordable housing – 91.220(j)

#### Introduction:

In 2015, the City of Erie of Erie adopted a Regional Analysis of Impediments to Fair Housing Choice. The analysis identified ten impediments, and proposed action steps to eliminate those impediments.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The City of Erie has identified fair housing education and services as a goal in the Consolidated Plan and Annual Action Plan.

#### Strategy to Remove or Ameliorate the Barriers to Affordable Housing

Actions it will take during the program year to continue to address the impediments is below:

- Impediment 1: The poor condition of much of the housing stock in Erie County affordable to lower-income households limits the array of neighborhoods from which they can choose to live. The City continues to provide incentives to build new apartment buildings or substantially rehabilitate existing buildings for occupancy by lower-income families. Since 2015, 89 new units have been constructed or rehabilitated for occupancy by low income households. The City continues to enforce the Rental Registration program, to ensure rental units are codecompliant. The Housing Authority of the City of Erie (HACE) continues marketing efforts to recruit new landlords for the Section 8 Program.
- Impediment 2: On the whole, household incomes during the last decade did not grow at a pace commensurate with housing costs, and members of the protected classes were more likely to be affected by the worsening mismatch. The City continues to financially support efforts of local fair housing organizations and certified housing counselors to advertise housing counseling. GECAC (HUD Certified Counseling Agency) offers service directed at all citizens including those New American and LMI households providing rent, utility, and mortgage assistance; credit, pre-purchase counseling and referral services. St. Martin Center (HUD Certified Counseling Agency) offers services directed at New American households and assists LMI households with rental, mortgage & utility assistance, food pantry, referrals, case mgmt., PA Workwear and crisis services; credit, pre-purchase counseling and referral services. Advantage Counseling (HUD Certified Counseling Agency) offers credit, bankruptcy, pre-purchase and post purchase counseling.
- Impediment 3: While County land use and planning principles appear to be consistent with
  fair housing principles and best practices, the real power is exercised by municipalities, whose
  leaders and staff members may not unequivocally understand why or how to affirmatively
  further fair housing. Council members, elected officials, department heads and persons will be
  appointed to Planning/Zoning Commissions on fair housing rights and responsibilities.
- Impediment 4: The growing Hispanic population in the City of Erie, along with other refugee and migrant groups, may face language barriers in becoming aware of, accessing and

- participating in local housing programs and services. The City continues to provide language and translation services on an as-needed basis for LEP populations.
- Impediment 5: Some of the policies and procedures of agencies administering federal housing and community development funds could be improved from a fair housing perspective. The City continues to reduce reliance on the CD Impact Area as a geographic basis for CPD program investment; instead evaluating neighborhoods city-wide to determine where investments would be most effective. The City reviews proposed locations of affordable housing developments during the Application Review Process to ensure developments are not perpetuating segregation.
- Impediment 6: The boundaries of program jurisdictions present obstacles to desegregation that must be addressed collaboratively. A more formal, regionalized effort among CDBG grantees and stakeholders could provide the basis seek funding to address impediments such as testing, education and outreach.
- Impediment 7: Limited public transit options and rising costs of transportation in general limit location options for many lower-income households. The City continues to participate in EMTA's long-range planning efforts to promote the expansion of public transit service for this population. During its underwriting and market analysis of HOME projects, DECD includes an assessment of access to transit, employment and economic opportunities.
- Impediment 8: Fair housing advocacy agencies in the County require more effective
  coordination to maximize the extent to which their services collaboratively meet the needs of
  Erie County residents. St. Martin Center, GECAC & Advantage Counseling Services counsel
  credit, homebuyer and homeowner clients on their rights and provide information on Fair
  Housing one on one and in group settings.
- Impediment 9: Housing discrimination persists in the private market, according to complaints
  data received at the federal, state and local levels. The City continues education and outreach
  efforts in relation to fair housing including publication of such material online, in print and other
  means.
- Impediment 10: Patterns of disparity continue to exist in private mortgage lending. The City continues to work with St. Martin Center, Inc. GECAC, & Advantage Counseling Services to mitigate impacts of foreclosure by supporting increased buyer education and counseling as well as supporting legislative protections.

The City of Erie has developed the following actions to address the following city needs: obstacles to meeting underserved needs; fostering affordable housing; reducing lead-based hazards; reducing the number of families living in poverty; developing institutional structures; and enhancing coordination between public and private housing and social service agencies.

#### Actions planned to address obstacles to meeting underserved needs

The City of Erie will continue to address the obstacles to meeting underserved needs through ongoing programs, including updating infrastructure and community facilities, community development, and housing needs throughout the City of Erie.

#### Actions planned to foster and maintain affordable housing

The City of Erie will fund activities that increase affordable rental units in the City, including providing incentives to developers to create new units and preserve existing units. The City of Erie will continue the owner and rental rehabilitation programs to make sure that the City of Erie's existing housing stock is up to code. Finally, the City of Erie will provide down payment and closing cost assistance to first-time homebuyers in the City.

#### Actions planned to reduce lead-based paint hazards

The Erie Redevelopment Authority will continue implementation of its lead hazard grant, and the City of Erie through the implementation of its rehabilitation programs will ensure interim controls are implemented to reduce the lead-based paint hazards in the City's housing stock.

#### Actions planned to reduce the number of poverty-level families

The City of Erie, through its various departments, will continue to provide incentives for businesses to locate in low income areas, to support organizations that provide job training and placement services through the Training Assistance Program Fund, to support rapid rehousing activities, and to preserve and improve affordable housing options, as part of its strategy to prevent and alleviate poverty in the City of Erie.

In addition, the Housing Authority of the City of Erie will continue to offer the Section 8 and public housing homeownership programs, which offer assistance for current residents to convert their rental assistance to mortgage assistance. In addition, the Housing Authority will continue the Family Self Sufficiency program to assist residents with improving wealth and provide budgeting and other services to promote self-sufficiency.

GECAC will continue providing adult education and employment services designed to lift households out of poverty.

#### Actions planned to develop institutional structure

The main gaps in the current institutional structure and service delivery system are related to limited funding and staffing for the various agencies and other stakeholders that the City of Erie relies on to implement its five-year strategy and to address the specific needs identified in the plan.

The City of Erie will continue to support the work of these agencies and stakeholders, including their efforts to identify, increase and obtain the amount of funding that is available to address the needs of their clients.

## Actions planned to enhance coordination between public and private housing and social service agencies

The City of Erie is a member of the Continuum of Care and participates in all planning processes associated with the Continuum. The County lead continues to reach out to church groups and other providers that do not currently participate in the Coordinated Entry System. These efforts will continue over the five-year period to ensure that all persons experiencing homelessness or are at-risk will be property evaluated and directed to the appropriate services.
